Technology First

Ohio is the first state in the country to place an emphasis on expanding access to technology for people with developmental disabilities, thanks to the Technology First Executive Order signed by Gov. John Kasich earlier this year.



Under the executive order, the Ohio
Department of Developmental Disabilities
(DODD) will work with county boards to ensure
technology is considered as part of all service
and support plans for individuals with
disabilities. It's designed to help people learn
more about how to use technology to improve
their quality of life and experience more
independence. It could also be an important
tool at a time when there's a significant direct
care shortage in Ohio.

Technology that can support a person from a distance is known as supportive technology using cameras or sensors, two-way communication, and backup support that's offsite.

Kyle Corbin, DODD's technology project manager, recently met with local providers to discuss the benefits of assistive technology and remote support, including the cost savings.

More than 325 people in 61 counties are using remote support services – none in Richland County.

"Our goal is 600 people by July 2019," Corbin said. "I think it's really, really achievable."

There are currently six vendors that do remote monitoring in Ohio. Corbin says they are the experts who determine what technology someone might be able to utilize.

Statehouse rally

Hundreds of people from across Ohio descended on the Statehouse in Columbus on Sept. 27 for the Bridge2Equality National Workforce Crisis Awareness Day rally.

The event was designed to raise awareness of the ongoing shortage of direct support professionals (DSPs). In Ohio and nationwide, the industry has struggled to recruit and retain a sufficient supply of qualified workers who assist people with disabilities in their homes, on the job, and during activities.

One of the featured speakers at the rally was Nicolas Comstock, a member of the Richland County Board of Developmental Disabilities



who also receives services from Richland Newhope. He spoke about how the shortage has impacted him directly and why it's important to address some of the issues contributing to the DSP shortage, including pay.

"Today I'm here to speak on behalf of those, a lot of those, who do not have a voice," said Nick. "I am all for people getting paid a reasonable wage to support their families. But we also need DSPs just not concerned about money. We need DSPs concerned about their individuals that they care for and their well-being."

Also in attendance at the rally were Courtney, who receives supports from Richland Newhope, along with her mother, Donna, and a Newhope staff member.
